The year ended March 2025 posed several challenges in regard to our trading business. Our trading activities are largely in the area of supply or distribution of oils, lubricants, batteries, agro chemicals, and electrical goods. We continued with efforts to achieve excellence in various fields, and to meet targets for the individual trading accounts.

Revenue from Operations was Rs 64.82 Crore during Fiscal 2025 which was a marginal increase compared to the previous year. Operational Profit (after excluding sale of property last year as well as the dividend income) was also higher than the previous year.

Distribution of batteries continued to be a major business during the year and is expected to grow further in future. Our principal has diversified into the sale of automotive and industrial lubricants. Future plans of the principal include auto components and tyres. We will continue to be associated with all such new businesses.

Business performance of the Fuel Retail Outlet was good during the year. Demand from our Outlet is expected to grow further from the coming year with the expected commissioning of the flyover in our proximity.

Distribution of lubricants both at Yamunanagar as well as Himachal Pradesh remained satisfactory in a business environment characterized by severe competition, chaotic working, and poor commitment levels. During the year, we continued to expand the distribution activity of electrical goods, especially Havells/Lloyd make air conditioners. Electrical consumer durables are, of course, prone to wide demand fluctuation as a result of climate variations.

Considering the severe competition in almost every trading area, as well as cut-throat prices, we made concerted efforts during the year to cap avoidable expenditure and improve productive utilization of resources.

During the year, the Company continued with its efforts to enlarge area of operation, increase the market share, and identify new product lines for trading.

We continued to retain our focus on safety, quality, and customer service. During the year, our field marketing & sales staff attended several training programs organized by the respective principals. The business outlook for the current year will continue to pose challenges in terms of severe competition as well as pressure on prices. Nonetheless, overall business performance is expected to be good. Finally, I would also like to take this opportunity to thank you all for your continued faith in The Yamuna Syndicate Limited and its Management.
